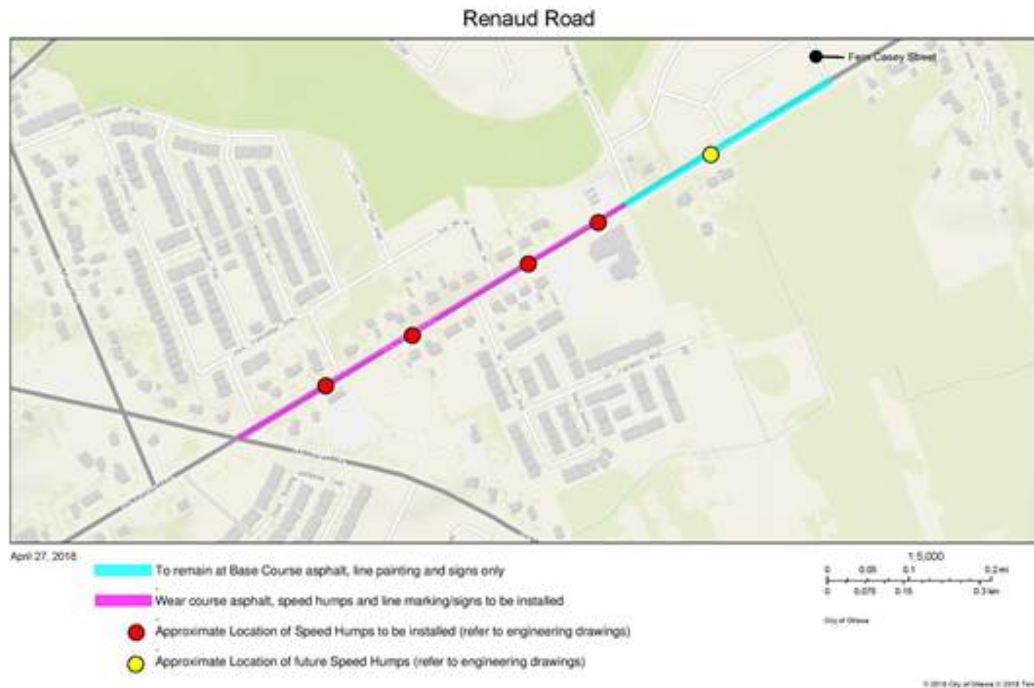

Thank you for the update. I only have a couple of questions :

1. Re: speed humps between Fern Casey and White streets. From what I understood (and the drawings I sent you from the public consultation) the speed humps were to be installed in front of both schools? Fern Casey to White is not in the area of study.

Staff clarified this and, yes, you are correct.



2. ATM study on Renaud to Bradley Ridge park: is this ANOTHER study? One was completed last year. Or is this a continuation/ modification of last year's study based on the results of last year's public consultation/survey? **This is the updated version based on public consultation and my meetings with staff. The results will be presented to the community for feedback. I will make sure the CA receives an update prior to it going to the public.**
