Hello,

I am following up on the Percifor to Brian Coburn Pathway after a conversation with Laura at the Community Council meeting this past Monday where I brought up this issue following my two previous emails. Laura confirmed (please correct me if I am mistaken) that she spoke to the landowner "Riviere" and the developer. I was unable to determine who the developer was, as far as it is known the land is privately owned and owned by NCC. She indicated that the city has advised (as they have to us all along) that the slope is too steep for a pathway and would require significant construction for it to be accessible (wheelchair, etc) to all. It continues to be included in the Brian Coburn Extension alternative solutions, and will be included in the design (if one of those options is selected).

I continue to push for safey improvements on Navan Road between Renaud and Brian Coburn. Laura indicated that she will push Taggart to include this when they develop the commercial land, but in my opinion, that is still too far off since that design/corner of land hinges on the Brian Coburn alternate extension design, and is years off. Safety improvements are required immediately.

I proposed improved lighting and temporary sidewalks along Navan, as they installed on Renaud Road from Navan to the school, until the sidewalks were built permanently. These temporary sidewalks are currently on Renaud Road west of Navan.

LED retrofit lighting is supposed to be rolling out through the city, and most of

Orleans has had street lights replaced with LED lights. Navan Road, Renaud Road, and Bradley Estates have yet to be upgraded.
