The facts I have received from Mike Giampa do indeed confirm that they are to be installed in the location you indicated in your public post. This is very unfortunate since it does not address the issue of the pedestrian crossing.

A quick phone call from you over the past few weeks would have been appreciated and could have prevented all of this confusion, and the need for **another** community meeting.

Please, in future, keep BECA apprised of these developments and plans, including meetings you are planning, so that we can be informed. I appreciate that you do not have all the background information and I have been doing my best to provide you with as much information as possible, including when we met back in November.

I'll be available for a phone meeting next week. Just waiting for confirmation from Chelsey, she's indicated you've been very busy.
